The non-profit organizations will be responsible for the health and well-being of the children in their care. BrighPoint allows donors to support these organizations by providing the infrastructure for the donors to sponsor these children.

Sponsorship Services:

Our sponsorship services provided support to 16 partners across 11 countries. Through these partners, we have 1,986 donors sponsoring the basic needs (food, clothing, shelter, adult care), primary and secondary school fees and clothing, and leadership development needs of 2,250 children. Our sponsors donated \$1,096,588 for child sponsorship through us in 2014 (as agency transactions), and we distributed \$997,980 of those funds to our partners so they can serve impoverished and at-risk children around the globe.

BrightPoint Children's Homes:

For the homes we support directly, our 174 donors sponsor 93 children. This allows us to provide for the child's basic needs (food, clothing, shelter, adult care), primary school needs, secondary school fees, security services, as well as health and well-being care.

FIFTEEN Leadership Program:

Our FIFTEEN leadership program started to provide leadership and life skills development for 26 students attending Osborne High School in Cobb County, GA. Osborne's graduation rate was 48% in 2013 and we started a three leadership program trying to abate this issue. Our program takes place over four hours every other Saturday during the school year. In addition to the 26 sophomores in our Class of 2016, we interviewed another 28 for the new class starting in the spring of 2015.
