AS PART OF ITS SPONSORSHIP SERVICES, BRIGHTPOINT PROVIDES A WEBSITE PRESENCE, ACCOUNTING, SPONSORING EVENT COLLATERAL, COLLECTIONS AND DISBURSEMENTS, CHILD AND SPONSOR LETTER TRACKING, YEAR-END TAX STATEMENTS AS WELL AS OTHER SERVICES THAT ARE NEEDED FOR THEIR MINISTRY PARTNERS TO SPONSOR THE CHILDREN IN THEIR CARE. IN RETURN FOR PROVIDING THESE SERVICES, BRIGHTPOINT CHARGES AN ADMINISTRATION AND OTHER FEES, INCLUDING CREDIT CARD FEES, AGAINST THE COLLECTED FUNDS BEFORE DISBURING THE REMAINING COLLECTED AMOUNTS TO THE PARTNER ORGANIZATION IN THE SUBSEQUENT MONTH TO COLLECTION. THE SERVICES AND FEES CHARGED ARE AGREED TO BETWEEN BRIGHTPOINT AND ITS MINISTRY PARTNERS AS OUTLINED IN A MEMORANDUM OF UNDERSTANDING BETWEEN PARTIES.
